**ORDER:**

In the Government Order first read above, orders have been issued permitting the Director of Public Health and Preventive Medicine to engage 2715 Multipurpose Health Worker (Male) on outsourcing on temporary basis at consolidated pay of Rs.20,000/- per month for a period of 3 months for prevention and control of COVID-19 pandemic.

2. In the Government Order second read above orders have been issued ratifying the action of the Director of Public Health and Preventive Medicine in having directed the Deputy Director of Health Services to fill up the 334 posts of Health Inspector Grade-II on consolidated pay of Rs.20,000/- per month through outsourcing for a period of 2 months without getting prior approval of the Government.

3. In the Government order third read above, orders have been issued permitting the Director of Public Health and Preventive Medicine to extend the period of outsourced Multi Purpose Health Worker (Male) / Health Inspector Grade-II up to

September 2020 and also accorded sanction for a sum of Rs.48,24,67,662/- (Rupees Forty Eight Crore Twenty Four Lakh Sixty Seven Thousand Six Hundred and Sixty Two only) for payment to the 3049 Outsourced Health Inspector Grade-II who are engaged in COVID-19 Pandemic Work from April 2020 to September 2020 at the rate of Rs.26,373/- per individual per month.

4. In the Government Order fourth and fifth read above, orders have been issued permitting the Director of Public Health and Preventive Medicine to extend the period of 1646 outsourced Multipurpose Health Worker (Male) / Health Inspector Grade-II appointed for prevention and control of COVID-19 pandemic work for a further period from October to December 2020 and January 2021 to February 2021 respectively.

5. In the Government order sixth read above the Government have extended the contract period of 1646 (334+1312) outsourced Multipurpose Health Worker (Male) up to May 2021 temporarily on the same terms, subject to the condition that their employment does not exceed 360 days.

6. In the letter seventh read above, the Director of Public Health and Preventive Medicine has stated that in view of the current increased incidence of COVID-19 cases and considering the nature of the transmission of the disease in the State, that department needs for engaging the additional Multipurpose Health Workers (Male) to the containment activities at the field level throughout the State. He has requested the Government to grant permission to fill up the remaining 1403 Multi Purpose Health Worker (Male).

7. The Government after careful examination decided to extend the outsourced 1646 Multipurpose Health Worker (Male) / Health Inspector Grade-II. Accordingly the Government do and hereby issue the following orders:-

- i. the Director of Public Health and Preventive Medicine is permitted to extend the period of 1646 outsourced Multipurpose Health Worker (Male) / Health Inspector Grade – II for another six months period from June 2021 to November 2021 by utilizing National Health Mission fund.
- ii. The Director of Public Health and Preventive Medicine is permitted to meet the financial commitment involved in this proposal amounting to Rs.26,04,59,748/- (1646 Nos. x 6 months x Rs.26,373/-) (Rupees Twenty six crores four lakh fifty nine thousand seven hundred and forty eight only) for payment to the 1646 outsourced Multipurpose Health Worker (Male) / Health Inspector Grade-II who are engaged in Covid-19 pandemic work from June 2021 to November 2021 from National Health Mission Fund.
- iii. The Mission Director, National Health Mission is instructed to release the amount in para 8 (ii) above to the Director of Public Health and Preventive Medicine from the National Health Mission fund by obtaining EC meeting approval / Circulation note for utilising the National Health Mission Fund.

8. This order issues with the concurrence of Finance Department vide its U.O.No.20110/Health-I/2021, dated 10.5.2021.
