ORDER:

The Institute Head, Sri Chakra Institute of Paramedical Science, Udumalpet, Tiruppur has requested the Government to grant permission to start two years Diploma in Medical Laboratory Technology course in the name and style as Sri Chakra Institute of Paramedical Science, Udumalpet, Tiruppur District with an annual intake of 15 students from the academic year 2019-2020.

2. In the Government letter first read above, the Director of Medical Education was requested to conduct an inspection on the premises of the said institution as per the norms and to furnish their recommendations.

3. The Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Allied Health Sciences has fulfilled the conditions prescribed by the Government norms and has submitted the proposal with the Inspection Report / Project Report along with his specific recommendation to the Government and requested to issue necessary orders.

4. In his letter second read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled all the norms prescribed by the Government and recommended to grant permission to the Sri Chakra Institute of Paramedical Science, Udumalpet, Tiruppur to start 2 years Diploma in Medical Laboratory Technology (DMLT) course with an annual intake of 15 students at Sri Chakra Institute of Paramedical

Science Udumalpet Taluk, Tiruppur District from the academic year 2019-2020.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Institute Head, Sri Chakra Institute of Paramedical Science, Udumalpet, Tiruppur to start 2 years Diploma in Medical Laboratory Technology (DMLT) course with an annual intake of 15 students at Sri Chakra Institute of Paramedical Science in S.F.Nos.4/147, 148, Udumalpet Taluk, Tiruppur-642 126 from the academic year 2020-2021, before admitting the students, subject to the following conditions:-

- i. The Trust should obtain the building completion certificate from the competent authority ie. PWD authority.
- ii. The Trust should obtain building plan approval from the Directorate of Town and Country Planning.
- iii. The Trust should obtain No Objection Certificate from the Fire and Rescue Service Department, Tiruppur District for the proposed Paramedical Institution.

6. The Director of Medical Education is directed to take necessary further action accordingly.
