ORDER:

3. The holders of the posts are eligible to draw besides pay in the time scale of pay of Rs. 4800-10000/- with Grade Pay of Rs. 1300 Dearness Allowance/ House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.
