ORDER:-

The Director of Medical Education, in his letter second read above, has stated among others that G.O.Ms.No.68, Health and Family Welfare Department, dated 14.03.2017, Government have granted permission to start two years Post Doctoral Fellowship Programme in Gynaec Oncology at the Institute of Obstetrics and Gynaecology and Government Hospital for Women and Children, Egmore, Chennai from the year 2016-17 with an annual intake of two seats subject to the following conditions:

'The eligibility criteria for the course will be MD (O&G) or DM (Oncology) or DNB (Oncology / OG) from any recognized University with full registration / State Medical Council';

2. The Director of Medical Education has also stated that the Director and Superintendent, Institute of Obstetrics and Gynaecology and Government Hospital for Women and Children, Chennai has stated that Gynaec-Oncology is a field that deals with Gynaecological cancers, which are primarily managed by Surgery. Cancer surgery needs special expertise and cannot be performed by people without specialized training. DM (Oncology) is a Medical speciality and DM / DNB oncology candidates lack exposure even in basic skills. Hence, he has requested the Government to issue suitable amendment to G.O.Ms.No.68, Health and Family Welfare Department, dated 14.03.2017 by changing eligibility criteria with regard to qualification as "MD/MS (O&G or DNB (O&G)" instead of DM (Oncology).

3. The Government have examined the proposal of the Director of Medical Education in detail and decided to amend the eligibility criteria for the two years Post Doctoral Fellowship Programme in Gynaec Oncology at the Institute of Obstetrics and Gynaecology and Government Hospital for Women and Children, Egmore, Chennai to be started in the said Institute. Accordingly, the Government do and hereby direct that the following amendment be issued to the G.O.Ms.No.68, Health and Family Welfare Department, dated 14.03.2017:

AMENDMENT

For the sub-para ii of the paragraph 2 mentioned in the G.O.Ms.No.68, Health and Family Welfare Department, dated 14.03.2017, the following paragraph shall be substituted:

"ii. The eligibility criteria for the course will be MD (O&G) / M.S.(O&G) or DNB (O&G) from any recognized University with full registration / State Medical Council'.
