#### ORDER:-

In his letter first read above, the Director of Medical Education has sent the proposal for redeployment of one Post of Associate Professor and one post of Senior Resident / Assistant Professor for Vascular Surgery Department at Coimbatore Medical College, Coimbatore. He has requested the Government to issue necessary orders for redeployment of one post of Associate Professor of Thoracic Medicine, Government Thanjavur Medical College, Thanjavur and one post of OP Medical Officer, Coimbatore Medical College Hospital, Coimbatore as Associate Professor and Senior Resident / Assistant Professor of Vascular Surgery respectively to Coimbatore Medical College, Coimbatore and stated that due to redeployment of the above posts, there is no extra expenditure to the Government.

2. In the meantime, the Government in the Government Order second read above, streamline the posts sanctioned to the Government Medical Colleges under the control of the Directorate of Medical Education by taking into all the posts including the posts proposed by the Director of Medical Education. It is found that no posts have been allotted to the speciality of Vascular Surgery in the Government Coimbatore Medical College, Coimbatore. The Coimbatore Medical College Hospital is one of the major medical institutions. The Vascular Surgery Department is not available and no posts are sanctioned for the above specialties in their Hospital. Hence, the patients who suffered with Vascular diseases, almost attended the Private Medical Institutions. But, it has been identified that the two posts in the speciality of Vascular Surgery as excess at Kilpauk Medical College and Madras Medical College, Chennai in the cadre of Professor and Assistant Professor respectively.

- 3. In view of the above, the Government have examined the proposal of the Director of Medical Education in detail and in the light of the orders issued in the Government Order second read above, and decided to downgrade the post of Professor of Vascular Surgery sanctioned to the Kilpauk Medical College, Chennai as Associate Professor of Vascular Surgery and to redeploy the said post to the Government Coimbatore Medical College, Coimbatore and to redeploy the post of Assistant Professor of Vascular Surgery sanctioned to the Madras Medical College in G.O(4D)No.2, Health and Family Welfare Department, dated 15.2.2019 to the Government Coimbatore Medical College, Coimbatore. The Government accordingly, hereby direct that the following orders are issued:
  - i. The post of Professor of Vascular Surgery sanctioned to Government Kilpauk Medical College in G.O(4D)No.2, Health and Family Welfare Department, dated 15.2.2019 be downgraded as Associate Professor of Vascular Surgery and be redeployed the said post to the Government Coimbatore Medical College, Coimbatore.
  - ii. The post of Assistant Professor of Vascular Surgery sanctioned to Madras Medical College, Chennai in G.O(4D)No.2, Health and Family Welfare Department, dated 15.2.2019 be redeployed the above said post to the Government Coimbatore Medical College, Coimbatore
- 4. The expenditure towards pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-

"2210 Medical and Public Health 05 – Medical Education – Training and Research – 105. Allopathy - – State's Expenditure – AH - Coimbatore Medical College, Coimbatore – 01 – Salaries". (DPC 2210-05-105-AH-0109)
