ORDER:-

In the Government order first read above orders have been issued to increase the intake capacity of in Under Graduate Course from 20 students to 60 students in the Government of Yoga & Naturopathy Medical College, Chennai from the academic year 2014-2015 and in the G.O second read above, orders have been issued for starting of 3 years Post Graduation Course in Yoga & Naturopathy viz, M.D in three branches i.e M.D (Acupunture), M.D (Naturopathy) and M.D (Yoga) with an annual intake capacity of 5 students in each branch and admission were made to the courses from the 2014-2015 academic year itself.

2. The Additional Chief Secretary /Commissioner of Indian Medicine and Homeopathy has stated that the Government Yoga &Naturopathy Medical College, Chennai. was established in the year 2000 in the of Aringnar Anna Government Hospital of Indian Medicine campus with an annual intake of 20 students per year in the Under Graduate course in Yoga and Naturopathy. The Tamil Nadu Dr. M.G.R Medical University while according conditional provisional affiliation to admit students to the Post Graduate/ Under Graduate Courses has stipulated to fulfill the shortfall noted in the inspection report within three months and one among the shortfall observed by the University is that Hostel accommodation shall be made available for the students both Male and Female separately. It is mandatory for the post Graduate Students both male and Female to stay in College campus as they have to attend

Out Patient and IP Ward (Which is about to start) including night duty as part of their curriculum. Hence Hostel for Post Graduate students is absolutely essential for them to stay nearby to the College and Hospital. The College has absolutely no hostel facility for boys pursuing Under Graduate Courses also.

- 3. The Principal Secretary / Commissioner of Indian Medicine and Homoeopathy Department has furnished the rough cost estimate of the work for construction of Gents Hostel for Government Yoga & Naturopathy Medical College at Arignar Anna Government Hospital of Indian Medicine, Chennai with a cost of Rs.520.30 lakh (Rupees five hundred twenty lakh and thirty thousand only) obtained for Engineer-in Chief (Buildings), Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai and requested to accord necessary administrative and financial sanction for the construction of Gents Hostel for Government Yoga & Naturopathy Medical College at Arignar Anna Government Hospital of Indian Medicine, Chennai at an estimated amount of Rs.520.30 lakh (Rupees five hundred twenty lakh and thirty thousand only)
- 4. The Government have examined the proposal of the Additional Chief Secretary / Commissioner of Indian Medicine and Homoeopathy and accord administrative and financial sanction for a sum of Rs.520.30 lakh (Rupees five Crore twenty lakhs and thirty thousand only) towards construction of Gents Hostel for Government Yoga & Naturopathy Medical College at Arignar Anna Government Hospital of Indian Medicine, Chennai.
- 5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:

"4210 Capital Outlay on Medical and Public Health – 03. Medical Education, Training and Research – 200. Other System – JA. Buildings – 16. Major Works" (DPC 4210 – 03 – 200 – JA – 1609)

6. The expenditure sanctioned in para 4 above is an item of "New Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Additional Chief Secretary/ Commissioner of Indian Medicine and Homoeopathy Department is directed to apply for sanction of advance from the Contingency Fund to Finance (BG-1) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. The Additional Chief Secretary / Commissioner of Indian Medicine and Homoeopathy Department is also directed to send draft explanatory notes for

including the above expenditure in the Revised Budget estimate 2016-2017 / First Supplementary Estimate 2016-2017 to Finance (BG-I/Health-I) Department without fail.
