ORDER:

The Project Director, Tamil Nadu Health Systems Project has reported that Tamil Nadu Health Systems Project has been conducting Hospital Administration training to Joint Directors, Deputy Directors, Chief Medical Officers of Government hospitals through Anna Institute of Management, Chennai, from 2008-09, that during the past five years around 1300 Senior Medical Officers have been trained and that the training is residential in nature and conducted for 10 days. As the training has been well received by the trainees, as per the positive feedback provided by them, the Project Director has proposed to impart the training during 2014-15 also. For the above purpose, the Project Director, Tamil Nadu Health Systems Project had placed a proposal before the State Empowered Committee in the meeting held on 01.08.2014 for sanction of Rs. 58.80 lakh towards conducting the Hospital Administration Training. The State Empowered Committee had approved the proposal. The Project Director has requested the Government to issue orders in the matter.

2. This activity has been approved by the World Bank and comes under Component IV and Sub-component B. The expenditure is eligible for reimbursement from the World Bank.

3. The Government after careful consideration accord sanction for incurring an additional expenditure of Rs. 58.80 lakh (Rupees fifty eight lakh and eighty thousand only) towards conducting the Hospital Administration training for the Joint Director of Health Services /Deputy Director of Health Services / Medical Officers under the control of Director of Medical & Rural Health Services and Deans of

Medical Colleges, Professors / Associate professors working under the control of the Director of Medical Education, as detailed below:
