ORDER:-

3. The holder of the post is eligible to draw besides pay in the time scale of pay of Rs.5200-20200/- with Grade Pay of Rs.2800/-, Dearness Allowance, House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.

4. The expenditure shall be debited to the following Head of Account:-
