ORDER:

The Project Director, Tamil Nadu Health Systems Project, has reported that Thiru.C.S. Ramalingam, is working as Assistant Executive Engineer, Engineering Cell in Tamil Nadu Health Systems Project with effect from 03.08.2009 and that he has represented for revision of contract pay. The Project Director has proposed to revise the contract pay paid to him. For this purpose, the Project Director, Tamil Nadu Health Systems Project had placed a proposal before the State Empowered Committee in the meeting held on 01.08.2014 for revision of contract pay from Rs.22,000/-p.m. to Rs.24,200/-p.m. The State Empowered Committee had approved the proposal. The Project Director has requested the Government to issue orders in the matter.

- 4. Sanction is accorded for incurring a recurring expenditure of Rs.26,400/-(Rupees twenty six thousand four hundred only) per annum towards payment of revised contract salary to Thiru.C.S. Ramalingam, Assistant Executive Engineer, Engineering Cell.
