ORDER:

In the circumstances reported by the Director of Medical Education in the letter third read above, the Government accord sanction for revival of one temporary post of Sanitary Worker attached to Government Arignar Anna Memorial Cancer Hospital, Karapettai, Kancheepuram which was originally created in the Government Order first read above and last continued in the Government Order second read above for the period from 18.04.2013 i.e from the date of relief from the old station.

2. Sanction is also accorded for further continuance of above said one temporary post of Sanitary Worker attached to Government Arignar Anna Memorial Cancer Hospital for the period from 18.04.2013 upto 30.06.2016 or till the need therefor ceases whichever is earlier.

3. The holders of the post is eligible to draw besides pay in the time scale of pay Rs.4800-10,000/- with Grade Pay of Rs.1300/- Dearness Allowance, House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.

4. The Expenditure shall be debited to the following Head of Account:-

“2210 – Medical and Public Health – 06 Public Health -101- Prevention and Control of Diseases I - Non Plan BY Cancer Control – 01 Salaries. (DPC 2210 – 06-101-BY - 0101)”

5. The Government also ratify the action of the Director of Medical Education in having filled up the above post in anticipation of the orders for revival from the Government.
