### **ORDER:-**

In the Government Order first read above, the Government issued Adhoc Rules for certain Technical posts including the post of Helper in the Tamil Nadu State Health Transport Department under Tamil Nadu Public Health Subordinate Service and amendments not issued so far to the above Adhoc Rules.

2. Subsequently, the Government in G.O.(Ms)No.1275, Health and Family Welfare Department, dated: 23.11.1992 issued orders to re-classify the post of Helpers as Fitter Grade-II and the post of Fitter and Fitter Grade-II were merged and redesignated as Fitter Grade-II vide G.O.(Ms)No.714, Finance (PC) Department, dated: 23.08.1994 and subsequently in G.O.(Ms)No.338, Finance (PC) Department, dated: 26.08.2010 Government issued orders, among other things, to redesignate the Grade-II (entry level posts) in all Government Departments as Skilled Assistant Grade-II and directed that the trade posts with practical experience (i.e) the category of Unskilled Assistants shall become defunct as and when the existing incumbents vacates the posts. Further, it was ordered that all future recruitments to the trade posts in all Government Departments / Local Bodies shall be made to the post of Skilled Assistant Grade-II (entry level posts) from among the I.T.I CERTIFICATE HOLDERS ONLY by giving due protection to the existing incumbents.

3. Consequent to the above orders, the Director, Tamil Nadu State Health Transport Department has requested the Government to issue amendments to the

Adhoc Rules for the entry level post of Helper (redesignated as Fitter Grade-II and then to Skilled Assistant Grade-II).

4. The Government after careful examination accept the proposal of the Director, Tamil Nadu State Health Transport Department.

5. The following Notifications will be published in the **Tamil Nadu Government Gazette.**

**NOTIFICATION - I.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Ad-hoc Rules published with the Health and Family Planning Department Notification S.R.O.No.B-199/74 at pages 198-212 of Part III - Section 1(b) of the Tamil Nadu Government Gazette, dated the 8<sup>th</sup> May 1974.

2. The amendment hereby made shall be deemed to have come into force on and from the 23<sup>rd</sup> November 1992.

**AMENDMENT.**

In the said Rules, for the expression "Helper" wherever it occurs, the expression "Fitter Grade II" shall be substituted.

**NOTIFICATION - II.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules published with the Health and Family Planning Department Notification S.R.O.No.B-199/74, at pages 198-212 of Part III - Section 1(b) of the Tamil Nadu Government Gazette, dated the 8<sup>th</sup> May 1974.

2. The amendments hereby made shall be deemed to have come into force on and from the 26<sup>th</sup> August 2010.

**AMENDMENTS.**

In the said Rules;-

1. for the expression "Fitter Grade-II" wherever it occurs, the expression "Skilled Assistant Grade-II" shall be substituted.
2. in rule 3, in the table, the entries in item (a) in column (2) against the entry "1.Helper" in column (1) thereof shall be omitted.
3. in rule 5, in sub-rule (b), in the table,
  - (a) the entries in item (a) in column (2) under the heading "Method of appointment" and the corresponding entries in column (3) thereof against the entry "1.Helper" under the heading "Posts" in column (1) shall be omitted.
  - (b) for the entries in column (3) against the entries "(b) by direct recruitment" under the heading "Methods of appointment" in

column (2) against the entry "1.Helper" under the heading "Posts" in column (1), the following entries shall be substituted, namely:-

- " (a) A pass in S.S.L.C or its equivalent.
- (b) National Trade Certificate in Mechanic (Motor Vehicle) Trade.
- (c) National Apprenticeship Certificate in Mechanic (Motor Vehicle) Trade".

4. after rule 8, the following rule shall be added, namely:-

**"9. Saving:-** Nothing contained in these Rules, shall adversely affect any person holding the post of Fitter Grade - II on the date of publication of these Rules.
