ORDER:

The Mission Director, State Health Society in his letter read above has stated 60% share of Grants in Aid has been transferred by Government of India to Tamil Nadu State Government under Centrally Sponsored Scheme for Integrated Disease Surveillance Programme during the year 2015-16.

2. Further, Government of India has requested to ensure 40% State contribution based on the release of funds by Government of India. The corresponding 40% of the State Share against the 60% of the Government of India release of **Rs.91,25,000/- (Rupees Ninety one lakhs and twenty five thousand only)** works out to **Rs.60,83,333/- (Rupees Sixty lakhs eighty three thousand three hundred and thirty three only)**. Since Government of India have transferred the grants to State Government for drawal of amount through Treasury route, the amount of State share will have to be drawn from State Budget.

3. The Mission Director, National Health Mission has requested the Government to issue orders for the release of a sum of **Rs.1,52,08,333/- (Rupees One crore fifty two lakhs eight thousand three hundred and thirty three only)** towards the release of Central and State Share contribution of grants in aid to the State Health Society under Integrated Disease Surveillance Programme during the year 2015-16 as mentioned above and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of **Rs.1,52,08,333/- (Rupees One crore fifty two lakhs eight thousand three hundred and thirty three only)** under National Health Mission through Treasury mode and credit into State Health Society Account.

4. The Government after careful consideration have decided to accept the above proposals of the Mission Director, State Health Society and accordingly sanction a sum of **Rs.1,52,08,333/- (Rupees One crore fifty two lakhs eight thousand three hundred and thirty three only)** towards the release of Central and State Share contribution of grants in aid to the State Health Society under Integrated Disease Surveillance Programme during the year 2015-16.
