ORDER:

In the G.O. read above, the Government have accorded sanction for conducting 33 batches of training on Treatment of poisoning, Intensive Medical Care and Basic Life Support.

2. The Project Director, Tamil Nadu Health Systems Project has reported that the Poison treatment centers are functioning well and that in many of these centers, the trained doctors have moved out and doctors need further training and the poison treatment centers are manned by staff nurses all the 24 hours and they also need intensive training. The Project Director has proposed to conduct the training to 10 additional batches.

3. For the above purpose, the Project Director, Tamil Nadu Health Systems Project had placed a proposal before the State Empowered Committee in the meeting held on 01.08.2014 for sanction of Rs. 29.25 lakh towards conducting the training on Treatment of poisoning, Intensive Medical Care and Basic Life Support. The State Empowered Committee had approved the proposal. The Project Director has requested the Government to issue orders in the matter.

4. This activity has been approved by the World Bank and comes under Component IV and Sub-component III. The expenditure is eligible for reimbursement from the World Bank.

5. The Government after careful consideration accord sanction for incurring an expenditure of Rs. 29.25 lakh (Rupees Twenty Nine Lakh and Twenty Five Thousand Only) towards conducting training on Treatment of poisoning, Intensive Medical Care and Basic Life Support in the Institute of Internal Medicine, Rajiv Gandhi Government General Hospital, & Madras Medical College, Chennai-3, as detailed in the annexure to this order.

6. The Project Director, Tamil Nadu Health Systems Project is permitted to conduct the training in 10 batches @ 10 Medical Officers and 20 Staff Nurses per batch. The training period will be 10 days. The training will be given in the Institute of Internal Medicine, Rajiv Gandhi Government General Hospital, & Madras Medical College, Chennai-3.

7. The Project Director, Tamil Nadu Health Systems Project is permitted to reallocate the non-recurrent expenditure within and across the components without exceeding the total amount sanctioned.

8. The expenditure sanctioned in para 5 above shall be debited to the following head of account:
