The Governor of Tamil Nadu having been satisfied that the lands in the schedule below are required for the purpose of provision of Project facilities such as construction of Junction Improvement to Chennai Outer Ring Road at 8.Vellachery Village and having already been decided that the entire amount of compensation to be awarded for lands is to be paid by the Highways Department and after having considered the cause shown by the owner or other person having interest in the said land, as the case may be, do hereby published the following notice under Sub/section 1 of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34/2002)
