From the Commissioner of Prohibition and Excise, Letter No.P&E 2 (4)/7779 /2017, dated 13.06.2018.

ORDER:-

In the letter read above, the Commissioner of Prohibition and Excise has stated that the Ministry of Tourism, Government of India have prescribed the revised guidelines for approval of hotels at Project stage and Star classification / Re-classification of operational hotels. Hence, there is a need to amend sub-clause (a) in clause (XVI) of Rule 2 of the Tamil Nadu Liquor (Licence and Permit) Rules, 1981. The Commissioner of Prohibition and Excise has therefore, sent the proposal to Government for incorporating the same in the said rule.

2. The Government after careful examination of the proposal of the Commissioner of Prohibition and Excise have decided to accept the proposal of the Commissioner of Prohibition and Excise and the following Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION.

In exercise of the powers conferred by section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Liquor (Licence and Permit) Rules, 1981.

AMENDMENT.

In the said Rules, in rule 2, in clause (XVI), for sub-clause (a), the following sub-clause shall be substituted, namely:-

“(a). that it has a minimum of ten lettable rooms, all rooms with outside windows / ventilation with attached bath rooms;”.


