### ORDER:

In the Government Order first read above, orders were issued for constitution of 8 Special Courts to deal with MCOP cases (in the cadre of District Judge) one each at Kancheepuram in Kancheepuram District, Tiruchirappalli in Tiruchirappalli District, Tiruppur in Tiruppur District, Tiruvallur in Tiruvallur District and 2 courts each at Coimbatore in Coimbatore District and Cuddalore in Cuddalore District. In the Government order second read above, orders were issued notifying the constitution of the above said 8 Special Courts in the **Tamil Nadu Government Gazette.**

2. The Registrar General, High Court of Madras, in the letter third read above, has requested the Government orders for publication of Notifications for Constitution of 8 Special Courts to deal with MCOP cases (in the cadre of

District Judge) one each at Kancheepuram in Kancheepuram District, Tiruchirappalli in Tiruchirappalli District, Tiruppur in Tiruppur District, Tiruvallur in Tiruvallur District and 2 courts each at Coimbatore in Coimbatore District and Cuddalore in Cuddalore District as Motor Accident Claims Tribunals and appointing the Presiding Officers of the said Courts as Members of the Motor Accident Claims Tribunals to try Motor Accident Claims Tribunal Original Petition cases under the Motor Vehicles Act, 1988 (Central Act 59 of 1988).

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the following Notifications shall be published in the Tamil Nadu Government Gazette.

#### NOTIFICATION-I

In exercise of the powers conferred by sub-section (1) of section 165 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby constitutes the Courts specified in column (3) of the Table below as Motor Accidents Claims Tribunal for the area specified in the corresponding entries in column (2) thereof:-
