ORDER:

The Registrar General, High Court of Madras, in his letter read above, has stated that the High Court, after considering the request of the Bar Association (Criminal side) and Advocate Association, Tiruchengode and in consultation with the Principal District Judge, Namakkal recommends the proposal for constitution of an Additional District Court at Tiruchengode in Namakkal District. In this regard, the Registrar General, High Court of Madras has stated that out of the 4128 cases pending on the file of the Principal District Court, Namakkal, Additional District Court, Namakkal and Fast track Court, Namakkal in Namakkal District as on 31.12.2018, 455 cases including 120 Original Suits, 45 Appeal Suits and 89 Session Cases are arising from the territorial jurisdiction of the proposed Additional District Court at Tiruchengode in Namakkal District. The aforesaid pendency of cases arising from the territorial jurisdiction of Tiruchengode justifies the necessity for constitution of an Additional District Court at Tiruchengode in Namakkal District.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for constitution of an Additional District Court at Tiruchengode in Namakkal District with requisite posts and other requirements.

3. During the Budget Session of the Tamil Nadu Legislative Assembly for the year 2020-2021, the Hon'ble Minister for Law, Courts and Prisons, while moving the Demand for Grants relating to Administration of Justice (Demand No.3) has made, among others, the following Announcement on the Floor of the Assembly on 20.03.2020:-

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the Government order for constitution of an Additional District Court at Tiruchengode in Namakkal District at a total expenditure of Rs.1,34,67,704/- (Rupees one crore thirty four lakh sixty seven thousand seven hundred and four only) (i.e. Rs.1,11,39,704/- as recurring expenditure and Rs.23,28,000/- as non-recurring expenditure) by sanctioning the following posts and other infrastructure facilities in relaxation of orders issued in G.O.(Ms).No.248, Finance (CMPC) Department, dated: 20.05.2020 and G.O.(Ms).No.249, Finance (BG-I) Department, dated: 21.05.2020.

5. The incumbents of the posts sanctioned in para-4 above are eligible to draw pay and other allowances as per orders in force.

6. The Director of Stationery and Printing, Chennai is directed to supply one Tamil Typewriter and one English Typewriter, stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.

7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court.

9. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The

Registrar General, High Court of Madras is directed to calculate the actual amount required for the period up to next supplementary estimates and apply for sanction of the same as advance from the Contingency Fund to the Government in the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued by the Finance(BG-I) Department. The Registrar General, High Court of Madras is also directed to send necessary explanatory notes to the Government in the Finance (BG-I/Home-II) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2020-2021 at the appropriate time without fail.


