ORDER:

In the circumstances reported by the Registrar General, High Court of Madras that 5022 original suits, 484 Appeal suits and 1514 sessions cases are pending in the I to VII and XV to XXIII Additional Courts and consequently, the work load in all the courts have considerably increased, the High Court has decided to transfer few original suits, Appeal suits and Sessions cases in the I to VII and XV to XIX Additional courts to the X Additional Special Court for the trial of cases under Prevention of Corruption Act,1988. The Registrar General, High Court, Madras has forwarded the draft Notification, under section 4(1) of the Chennai City Civil Courts Act, 1892 (Central Act VII of 1892), for notifying the X Additional City Civil Court at Chennai for exclusive trial of cases under Prevention of Corruption Act, 1988 (Central Act 49 of 1988), Chennai in the cadre of District Judge as Additional

Court under the said Act and requested the Government to cause the same published in the Tamil Nadu Government Gazette.

2. The Government after careful examination, accept the proposal. Accordingly, the following Notification shall be published in the Tamil Nadu Government Gazette.

NOTIFICATION.

In exercise of the powers conferred by sub-section (1) of section 4 of the Chennai City Civil Court Act, 1892 (Central Act VII of 1892), the Governor of Tamil Nadu, hereby appoints the Special Judge, X Additional City Civil Court at Chennai for exclusive trial of cases under Prevention of Corruption Act, 1988 (Central Act 49 of 1988), Chennai as the Additional Judge, X Additional City Civil Court, Chennai, with effect on and from the date on which the said Additional Judge assumes charge of the said court.
