### **ORDER:**

In the Government order first read above, the Government had constituted a State Road Safety Council under the Chairmanship of Minister for Transport with 18 Members. Further, in the Government orders second and third read above, the Government have issued orders for the inclusion of Chief General Manager, National Highways Authority of India and the Secretary to Government, Revenue and Disaster Management Department as Members in the State Road Safety Council.

- 2) The Transport Commissioner, has stated that the Member Secretary, Chennai Unified Metropolitan Transport Authority is the high level body to advice the Government on all policies and programmes relating to Road Safety and proposed to include the Member Secretary, Chennai Unified Metropolitan Transport Authority as one of the member (22<sup>nd</sup> Member) of the State Road Safety Council.
- 3) The Transport Commissioner has therefore requested the Government to issue necessary amendment to Government order first read above, by adding the Member Secretary, Chennai Unified Metropolitan Transport Authority as a Member of the State Road Safety Council.
