ORDER:-

The Hon'ble Chief Minister while replying to the Demand No.23 of the Fire and Rescue Services Department on 21.04.2023, among others, has made the following Announcement on the floor of the Tamil Nadu Legislative Assembly:-

"தீயணைப்பு மற்றும் மீட்புப் பணிகள் துறை பணியாளர்களுக்கு தற்போது வழங்கப்பட்டு வரும் காப்பீட்டு இடர் பாதுகாப்பு தொகை (Insurance Risk Coverage) உயர்த்தி வழங்கப்படும்".

- 2. In the Government Order first read above, the Government have introduced, a Special Group Insurance Scheme with the United India Insurance Company for the Welfare of the executive staff of the Tamil Nadu Fire and Rescue Services Department. Under this scheme, a sum of Rs. 1.00 lakh was payable to the legal heirs of the executive staff of the Fire and Rescue Services Department who die while on duty in the course of employment or in case of accidental death.
- 3. In the Government Order second read above, the Government have enhanced the insurance amount payable to the legal heirs of the executive staff of Tamil Nadu Fire and Rescue Services Department from the rank of fireman to Director of Fire and Rescue Services from Rs.1.00 lakh to Rs.2.00 lakh.

- 4. In the Government Order third read above, the Government have enhanced the the Group Insurance amount from Rs.2.00 lakh to Rs.4.00 lakh payable to the legal heirs of District Officers, Deputy Directors and Joint Directors, Fire and Rescue Services Department.
- 5. The DGP / Director, Fire and Rescue Services in his letter fourth read above has requested to enhance the insurance coverage of the fire personnel on par with the police personnel and recommended the following rates for enhancement.
