ORDER:

The Hon'ble Chief Minister, on the floor of the Legislative Assembly during the Budget Session for the year 2021-2022 in respect of the Forensic Sciences Department, among other things, has made the following Announcement:

2. In the Government Order first read above, the Government have accorded administrative sanction for a sum of Rs.4,46,35,065/- [i.e., Rs.83,51,865/- as recurring expenditure and Rs.3,62,83,200/- as non-recurring expenditure] and for creation of 8(Eight) new posts towards establishment of two Computer Forensics Division one each at the Regional Forensic Science Laboratories at Madurai and Trichy as detailed below:

In the Government Order second read above, the Government have accorded administrative and financial sanction for a sum of Rs.53,21,000/- for developing necessary infrastructure and Laboratory ambience at Regional Forensic Science Laboratories at Madurai (Rs.26.28 lakh) and Trichy (Rs.26.93 lakh), towards establishment of Computer Forensics Divisions.

4. In the circumstances reported by the Director(i/c), Forensic Sciences Department, Chennai, in his letter third read above, the Government accord financial sanction for a sum of Rs.3,59,99,894/- (Rupees three crore fifty nine lakh ninety nine thousand eight hundred and ninety four only) [i.e., Rs.3,53,99,894/- for purchase of software /hardware tools and Rs.6,00,000/- for purchase of Furniture, Computer, Printer and other Accessories], from and out of the administrative sanction amount of Rs.4,46,35,065/- accorded in the Government Order first read above, towards establishing Computer Forensics Division at Regional Forensic Science Laboratories, Madurai and Trichy. The Government also permit the Director, Forensic Sciences Department, Chennai to fill up newly created 8 (Eight) posts sanctioned in the Government Order first read above, towards establishing Computer

Forensics Division at Regional Forensic Science Laboratories, Madurai and Trichy.

5. The expenditure sanctioned at para-4 above, shall be debited to the following heads of account:-
