Budget session 2022-2023 – Announcement made by Hon'ble Chief Minister on the Floor of the Tamil Nadu Legislative Assembly - Purchase of Tablet PCs for Police Stations in Districts / Cities instead of old device for the implementation of "m-Passport" - Financial sanction – Orders – Issued.

ORDER:

In the Government Order first read above, orders were issued according administrative sanction for a sum of Rs.4,18,00,000/- towards purchase of 1675 numbers of 6 inches Tablet PCs for Police Stations in Districts / Cities instead of old devices for the implementation of "m-Passport" and for standby and emergency use in the districts. The Director General of Police / Head of Police Force was also directed therein to follow necessary purchase procedures while purchasing the 1675 numbers of 6 inches Tablet PCs and to send necessary proposals to Government for according financial sanction at the time of requirement with actual amount required for the purchase of Tablet PCs for Police Stations.

2. The Director General of Police / Head of Police Force, Chennai, in his letter second read above, has stated that the Additional Director General of Police, SCRB i/c Technical Services, Chennai has reported that for the purchase of 1675 numbers of 8 inches Tablet PCs for Police Stations in Districts / Cities for the implementation of "m-Passport", M/s.ELCOT Ltd., was requested to invite & process a separate tender on

behalf of Department within the allotted funds and obtained estimated invoice from M/s.ELCOT Ltd., Chennai, to the total sum of Rs.4,18,00,000/- for supply of the following item.

Hence, the Additional Director General of Police, SCRB i/c Technical Services, Chennai, has requested to address the Government for according financial sanction to the tune of Rs.4,18,00,000/- towards the advance payment to M/s.ELCOT, Ltd., Chennai, for supply of 1675 numbers of 8 inches Tablet PCs for Police Stations in Districts / Cities instead of old devices for the implementation of "m-passport".

- 3. The Director General of Police / Head of Police Force, Chennai has, therefore, requested the Government to issue necessary financial sanction to the tune of Rs.4,18,00,000/- towards advance payment to M/s.ELCOT Ltd., Chennai for supply of 1675 numbers of 8 inches Tablet PCs for Police Stations in Districts / Cities instead of old devices for the implementation of 'm-passport'.
- 4. The Government, after careful examination of the proposal of the Director General of Police / Head of Police Force, Chennai, have decided to accept it. Accordingly, the Government sanction a sum of Rs.4,18,00,000/- (Rupees Four crore eighteen lakh only) towards advance payment to M/s.ELCOT Ltd., Chennai for supply of 1675 numbers of 8 inches Tablet PCs for Police Stations in Districts / Cities instead of old devices for the implementation of `m-passport'.
- 5. The expenditure sanctioned in paragraph 4 above shall be debited under the following head of account:-

"2055-00-Police-114 Wireless and Computers - State's Expenditure AA Technical Services - 319 - Machinery and Equipments - 01 Purchase". (IFHRMS DPC: 2055-00-001-AA-31901)

6. The expenditure sanctioned in paragraph 4 above shall be met within the Revised Estimate 2022-2023 provisions. The Director General of Police / Head of Police Force is authorised to incur the expenditure sanctioned above.

7. This orders issues with the concurrence of the Finance Department vide its U.O.No.1609/Home-I/2023, dated 14.03.2023.
