ORDER

In the Government order first read above, orders were issued for the constitution of a separate Chief Judicial Magistrate Court at Udhagamandalam by bifurcating the existing District Judge-cum-Chief Judicial Magistrate Court at Udhagamandalam in the Nilgiris District with posts and other requirements.

- 2. The Registrar-General, High Court of Madras, Chennai, has sent a draft notification under sub-section (1) of section 11 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), for constitution of a separate Chief Judicial Magistrate Court at Udhagamandalam in the Nilgiris District with a request to publish the same in the <u>Tamil Nadu Government Gazette</u>.
- 3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it.

Accordingly, the Government direct that the following Notification shall be published in the <u>Tamil Nadu Government Gazette</u>:-

In exercise of the powers conferred by sub-section (1) of section 11 of Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby establishes a Court of Judicial Magistrate at Udhagamandalam in The Nilgiris District.
