#### ORDER:

The Hon'ble Minister for Law, while moving the Demand for Grants relating to Administration of Justice (Demand No.3), has made, among others, the following Announcement on the Floor of the Assembly on 7.9.2021:-

"Constitution of a Sub Court at Thirumayam in Pudukkottai District".

- 2. Based on the above Announcement, the Registrar General, High Court of Madras, has sent the proposal read above, for constitution of a Sub Court at Thirumayam in Pudukkottai District, wherein he has stated that the High Court, after considering the proposal from the Principal District Judge, Pudukkottai, recommends the proposal for constitution of a Sub Court at Thirumayam in Pudukkottai District. In this regard, he has stated that out of 3021 cases pending on the file of the existing Sub Court, Pudukkottai and Additional Sub Court, Pudukkottai as on 31.10.2021, 794 cases including 495 Original Suits, 43 Appeal Suits, 8 C.M.As, 161 All O.Ps, 24 M.C.O.Ps, 55 E.Ps, and 8 Session Cases are arising from the territorial jurisdiction of the proposed Sub Court, Thirumayam. The above number of Original Suits justifies the necessity for the constitution of a Sub Court at Thirumayam in Pudukkottai District.
- 3. The Registrar General, High Court of Madras has, therefore, requested the Government to issue necessary orders for constitution of a Sub court at Thirumayam in Pudukkottai District with posts and other requirements. He has also requested the Government for the attachment of the Copyist Establishment and Nazir Establishment now functioning at the District Munsif-cum-Judicial Magistrate Court, Thirumayam to the proposed Sub Court, Thirumayam.

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government accord sanction for a sum of Rs.1,87,36,088/- (Rupees one crore eighty seven lakh thirty six thousand and eighty eight only) [viz. Rs.1,71,38,588/- as recurring expenditure and Rs.15,97,500/- as non recurring expenditure] towards constitution of Sub Court at Thirumayam in Pudukkottai District by sanctioning 19 new posts and other infrastructure facilities.

- 6. The Director of Stationery and Printing, Chennai is directed to supply one Tamil Typewriter and one English Typewriter, stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.
- 7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.

Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I)

Department. The Registrar General, High Court of Madras is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022 at the appropriate time without fail.
