From the Registrar-General, High Court of Madras, Chennai, Letter Roc.No.48172/A/2019/G/Judn, dated, 08.10.2020 and 03.11.2022.

ORDER

The Registrar-General, High Court of Madras, Chennai, in his letters read above, has stated that the Madras High Court, after considering the request of the Rajapalayam Bar Association and in consultation with the Principal District Judge, Virudhunagar District at Srivilliputhur, has recommended the proposal for constitution of a Subordinate Judge's Court at Rajapalayam.

2. The Registrar-General, High Court of Madras has, therefore, requested the Government for constitution of a Subordinate Judge's Court at Rajapalayam in Virudhunagar District with fresh sanction of 34 posts along with other requirements at a total cost of Rs.1,43,37,800/- and attachment of the existing Nazerath and Copyist Establishment functioning at District Munsif Court, Rajapalayam with the proposed court. He has also requested that, on redeployment / attachment of the existing post of Deputy Nazir from the District Munsif Court, Rajapalayam, to the proposed Court, the post of Deputy Nazir may be re-designated as Central Nazir.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government accord sanction for constitution of a Subordinate Judge's Court at Rajapalayam in Virudhunagar District with creation of 15 new posts by fresh creation along with other requirements at a total expenditure of Rs.1,65,69,360/- (Rupees one crore sixty five lakh

sixty nine thousand three hundred and sixty only) [viz. Rs.1,48,65,860/- as recurring expenditure and Rs.17,03,500/- as non recurring expenditure] as detailed below:-

and apply for sanction of the same as advance from the Contingency Fund to the Government in the Finance (Budget General-I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued by the Government in the Finance (Budget General-I) Department. The Registrar-General, High Court of Madras, is also requested to send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2023-2024 to Finance (Budget General-I/Home-II) Department at the appropriate time, without fail.

The Registrar-General, High Court of Madras, is also requested to intimate the details of the DDO Code to the Government in the Finance (Central Man Power Cell) Department, as and when it is assigned to the Presiding Officer of the Subordinate Judge's Court at Rajapalayam, by the Treasury Officer, Virudhunganar, so as to enable to make necessary entries in the IFHRMS Portal.


