ORDER

The Registrar-General, High Court of Madras, Chennai, in his letter first read above, had stated that, after considering the request of the Principal District Judge, Tiruvannamalai and considering the pendency of the cases in the existing Subordinate Judge's Court, Cheyyar, the Hon'ble High Court has recommended the proposal for constitution of an Additional Subordinate Judge's Court at Cheyyar.

2. The Registrar-General, High Court of Madras, has, therefore, sent a proposal for constitution of an Additional Subordinate Judge's Court at Cheyyar in Tiruvannamalai District with 15 new posts and other requirements.

3. Meanwhile, the Hon'ble Minister for Law, while moving the Demand for Grants relating to Administration of Justice (Demand No.3), has made, among others, the following announcement on the floor of the Assembly on 10.04.2023:-

“Constitution of an Additional Subordinate Judge's Court at Cheyyar in Tiruvannamalai District”.

4. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it.

Accordingly, the Government accord sanction for constitution of an Additional Subordinate Judge's Court at Cheyyar in Tiruvannamalai Judicial District, with the following 14 new posts and other requirements at a total expenditure of Rs.1,48,84,316/- (Rupees one crore forty eight lakh eighty four thousand three hundred and sixteen only) [viz. Rs.1,33,41,316/- as recurring expenditure and Rs.15,43,000/- as non recurring expenditure] as detailed below:-

6. The Director of Stationery and Printing, Chennai, is directed to supply one Tamil Typewriter and one English Typewriter, other stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.

The expenditure sanctioned in paragraph 4 above shall constitute an item of “New Instrument of Service” and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates, 2023-2024. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Registrar-General, High Court of Madras, is requested to calculate the

actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Government in the Finance (BG-I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued by the Government in the Finance (BG-I) Department. The Registrar-General, High Court of Madras, is also requested to send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates, 2023-2024 to the Government in the Finance (BG-I/Home-II) Department at the appropriate time, without fail.

9. The Registrar-General, High Court of Madras, is also requested to intimate the details of the DDO Code to the Government in the Finance (Central Man Power Cell) Department, as and when it is assigned to the Presiding Officer of the Additional Subordinate Judge's Court at Cheyyar, by the Treasury Officer, Tiruvannamalai, so as to enable to make necessary entries in the IFHRMS Portal.


