### **ORDER:-**

In the Government order first read above, orders were issued for the constitution of an exclusive Motor Accident Claims Tribunal for trying and disposing of motor vehicle accident cases in the cadre of Sub-Judge at Namakkal in Namakkal District at a total expenditure of Rs.1,40,40,412/- by sanctioning 14 new posts and other infrastructure facilities.

2. The Registrar General in his letter second read above has requested that orders of the Government may be issued for the constitution of an exclusive Motor Accident Claims Tribunal in the cadre of Sub Judge at Namakkal and to appoint one Sub Judge, Namakkal in Namakkal District as a member of the Motor Accident Claims Tribunal, Namakkal District under sub-sections (1) and (2) of section 165 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) by issuing notification in the Tamil Nadu Gazette.

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept the

**ANNEXURE-I**  
**NOTIFICATION-I**

In exercise of the powers conferred by the first paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby alters the number of Subordinate Judges to be appointed under the said Act for Namakkal District as six with effect from the date on which the Subordinate Judge, Namakkal assumes charge of the exclusive Motor Accident Claims Tribunal at Namakkal.

**NOTIFICATION-II**

In exercise of the powers conferred by the second paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby fixes the number of Subordinate Judges to be appointed to the Subordinate Judge's Court at Namakkal in Namakkal District as three with effect from the date on which the Subordinate Judge, Namakkal assumes charge of the exclusive Motor Accident Claims Tribunal at Namakkal.

**NOTIFICATION-III**

In exercise of the powers conferred by section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes Namakkal as the place at which the Subordinate Judge's Court, Namakkal constituted as Motor Accident Claims Tribunal, Namakkal shall be held.

**NOTIFICATION-IV**

In exercise of the powers conferred by section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) the Governor of Tamil Nadu, hereby specifies the following area as the local limits of jurisdiction of the Motor Accident Claims Tribunal at Namakkal:-
