ORDER:-

The Hon'ble Chief Minister, on the floor of the Legislative Assembly during the Budget Session for the year 2021-2022 in respect of the Forensic Sciences Department, among other things, has made the following Announcement:

2. Pursuant to the above Announcement, the Director(i/c), Forensic Sciences Department, Chennai in his letter read above, has sent proposal for a sum of Rs.7,21,16,570/- towards establishment of DNA analysis Division in the Regional Forensic Science Laboratory at Thanjavur as detailed below:-

Accordingly, the Government accord administrative sanction for a sum of Rs.3,26,37,006/- (Rupees three crore twenty six lakh thirty seven thousand and six only) [i.e.,Rs.74,19,032/- as recurring expenditure and Rs.2,52,17,974/-as non-recurring expenditure] as detailed in para-4 above for establishment of DNA analysis Division in the Regional Forensic Science Laboratory at Thanjavur.

The Government also accord administrative sanction for creation of 5 (five) posts in various cadre towards establishment of DNA analysis Division in the Regional Forensic Science Laboratory at Thanjavur, as detailed below, temporarily for a period of one year from the date of filling up of the posts or until the need there for ceases, whichever is earlier:-

The Director(i/c), Forensic Sciences Department is directed to follow the necessary purchase procedure / Tender procedures as per rules in force towards purchase of Chemicals / DNA kits & consumables, Instruments and Apparatus, Furniture and Computer, Printer and accessories and to procure this items, after completion of construction of building and ready for occupation & installation of Instruments. The Director(i/c), Forensic Sciences Department is also directed that the posts sanctioned above are to be filled up only after instruments and apparatus are procured and installed in the proposed building and in accordance with statutory rules in force.

8. The Director (i/c), Forensic Sciences Department is directed to send separate proposal for financial sanction for the above sanctioned items at appropriate time and to send the detailed estimates for construction of building and infrastructure.




