ORDER:

The Hon'ble Chief Minister of Tamil Nadu, during the Police demand No.22, for the year 2021-2022 in the Tamil Nadu Legislative Assembly has among others made the following announcement:-

2. Consequent to the above announcement, the Director General of Police in the letter read above has sent a proposal wherein, he has requested to sanction 130 Executive posts and 11 ministerial posts as detailed below:-

3. The Government after careful examination have decided to accept the proposal of the Director General of Police and to accord sanction for 130 Executive posts and 11 ministerial posts on redeployment basis as listed in the Annexure – I and also accord sanction for a sum of Rs.17,88,56,791/- (Rupees seventeen crore eighty eight lakh fifty six thousand seven hundred and ninety one only) (Recurring Expenditure of Rs.13,71,53,791/- and Non Recurring Expenditure of Rs.4,17,03,000/- mentioned in Annexure-II) for the above expenditure required for 2021-2022. Details of Posts redeployed from various units are in the Annexure-III to this order. The Director General of Police is directed not to prefer claim for their posts in the original place.

4. The Director General of Police, Chennai is also directed to follow necessary purchase procedures in force and also to divert the post attached vehicles to the new stations alongwith redeployed posts.

The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" for which the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2021-2022. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director General of Police, Tamil Nadu, Chennai is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director General of Police / Head of Police Force, Chennai shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022, without fail.
