ORDER:

The Hon'ble Minister for Transport, while moving the Demand for Grants relating to Motor Vehicles Acts – Administration (Demand No.25), has made the following announcement on the floor of the Assembly on 08.09.2021.

"Construction of own building with Driving Testing Track for the Regional Transport Office, Madurai (South) at a total cost of Rs.528.00 Lakhs."

2. Pursuant to the above announcement, in the Government order first read above, the Government have accorded administrative sanction for a sum of Rs.3,78,00,000/- (Rupees three crores and seventy eight lakh only) towards the construction of own building for the Regional Transport Office, Madurai (South) and also directed that the Transport Commissioner to send necessary proposals for financial sanction.

3. The Transport Commissioner / Road Safety Commissioner has stated that, the District Collector, Madurai has granted enter upon permission for the following land towards construction of building to the Regional Transport Office, Madurai (South) vide proceedings in R.No.34615/2019/Y2, Dated 10.08.2020. The details are furnished below:-

The Transport Commissioner / Road Safety Commissioner has also stated that, the Engineer-in-Chief (Buildings), Public Works Department, Chennai-5 has sent the Detailed Estimate for the construction of own building to the Regional Transport Office, Madurai (South) in Madurai District. The details are as follows:-

The Transport Commissioner / Road Safety Commissioner has therefore requested the Government to sanction a sum of Rs.3,78,00,000/- (Rupees three crore and seventy eight lakh only) for construction of own buildings for the Regional Transport Office, Madurai (South), so as to implement the Announcement of the Hon'ble Minister for Transport made on the floor of the Legislative Assembly for the financial year 2021-2022.
- 6. The Government after careful examination, have decided to accept the proposal of the Transport Commissioner / Road Safety Commissioner. Accordingly, the Government hereby accord financial sanction for a sum of Rs.3,78,00,000/- (Rupees three crore and seventy eight lakh only) for construction of own buildings for the Regional Transport Office, Madurai (South).

7. The expenditure sanctioned in para 6 above shall be debited to the following head of account:-

"4059-Capital outlay on public works-01. - Office Buildings-051. Construction State's Expenditure - AR Transport Department - 416. Major works 01. Major Works".
