ORDER:

In the reference 1st read above, the Government have decided to declare a Public Holiday on the day of funeral of Thiru.A.P.J.Abdul Kalam, former President of India i.e. on 30.07.2015 for all Educational Institutions and for all Government / Private Establishments under Negotiable Instruments Act, 1881 as a mark of respect to the former President.

2. The Commissioner of Prohibition and Excise has requested that all the shops of TASMAL and bars attached thereto functioning throughout the State may be ordered to be closed on 30.07.2015, under rule 12(2) of the Tamil Nadu Liquor Retail Vending (in shops and bars) rules, 2003. He has also requested that he may be authorised to issue necessary directions for closure of FL series licensed premises i.e. FL2 to FL11 (except FL6) licences under the relevant rules of the Tamil Nadu Liquor (Licence and Permit) Rules, 1981, as a mark of respect to the former President.

3. The Government have decided to accept the above proposal of the Commissioner of Prohibition and Excise. Accordingly, under sub-rule (2) of rule 12 of the Tamil Nadu Liquor Retail Vending (in Shops and Bars) Rules, 2003, hereby direct that all the shops of TASMAC and the bars attached thereto functioning throughout the State be closed on 30.07.2015. The Commissioner of Prohibition and Excise is also requested to issue suitable directions under the powers vested with him under the relevant rules for the closure of the licensed premises of FL2 to FL11 (except FL6) licences throughout the State on 30.07.2015 as a mark of respect to the former President.

4. The Commissioner of Prohibition and Excise / Managing Director, Tamil Nadu State Marketing Corporation Limited / Director General of Police / Additional Director General of Police (Enforcement) / Additional Director General of Police (Law and Order) / all District Collectors shall take necessary action in this regard.
