ORDER:

The Registrar General, High Court of Madras, in his letter read above, has stated that the Government in various Government Orders have issued Orders for revenue bifurcation of Villupuram, Tirunelveli, Kancheepuram and Nagapattinam Districts and creation of new Districts viz., Kallakurichi, Tenkasi, Chengalpattu and Mayiladuthurai respectively and for Trifurcation of Vellore District and creation of new Districts viz., Tirupathur and Ranipet Districts. He has further stated that in view of the above Orders of the Government, and in consultation with the Principal District Judges / District Judges and Chief Judicial Magistrates concerned, the High Court has decided that the Judicial Districts are also to be bifurcated / trifurcated for the benefit of the litigant public and at the first instance, District and Sessions Courts and Chief Judicial Magistrate Courts are to be constituted in the newly formed districts.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue necessary orders, among others, for constitution of new Chief Judicial Magistrate Courts in the newly formed Kallakurichi, Tenkasi, Mayiladuthurai, Tirupathur and Ranipet Districts and in Kancheepuram District (since Chief Judicial Magistrate Court for Kancheepuram Distrit is now functioning at Chengalpattu), with posts and other requirements.

3. In the meantime, the Hon'ble Minister for Law, while moving the Demand for Grants relating to Administration of Justice (Demand No.3), has made, among others, the following Announcement on the Floor of the Assembly on 7.9.2021:-

- i. Constitution of a Chief Judicial Magistrate Court at Kallakurichi in Kallakurichi District.
- ii. Constitution of a Chief Judicial Magistrate Court at Tenkasi in Tenkasi District.
- iii. Constitution of a Chief Judicial Magistrate Court at Ranipet in Ranipet District.
- iv. Constitution of a Chief Judicial Magistrate Court at Kancheepuram in Kancheepuram District.
- v. Constitution of a Chief Judicial Magistrate Court at Mayiladuthurai in Mayiladuthurai District.
- vi. Constitution of a Chief Judicial Magistrate Court at Tirupattur in Tirupattur District."

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government accord administrative sanction for a sum of Rs.10,52,57,928/- (Rupees ten crore fifty two lakh fifty seven thousand nine hundred and twenty eight only) [viz. Rs.8,77,82,928/- as recurring expenditure and Rs.1,74,75,000/- as non recurring expenditure] and also sanction a sum of Rs.3,22,90,488/- (Rupees three crore twenty two lakh ninety thousand four hundred and eighty eight only) for the year 2021-2022 towards constitution of new Chief Judicial Magistrate Courts in the newly formed Kallakurichi, Tenkasi, Mayiladuthurai, Tirupattur and Ranipet Districts and in Kancheepuram District by sanctioning the following 120 new posts and other infrastructure facilities.

5. The incumbents of the posts sanctioned in para 4 above are eligible to draw pay and allowances as per orders in force.

6. The Director of Stationery and Printing, Chennai is directed to supply Two Tamil Typewriters and Two English Typewriters, stationery articles, requisite forms and registers to each of the newly sanctioned Chief Judicial Magistrate Courts in the newly formed Kallakurichi, Tenkasi, Mayiladuthurai, Tirupattur and Ranipet Districts and in Kancheepuram District at free of cost against the specific indent of the Judicial officers concerned.

7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under relevant acts for the commencement of the above said Courts.

8. The expenditure sanctioned in para 4 above shall be debited to the following heads of account:-

9. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Registrar General, High Court of Madras is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the contingency fund to the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department. The Registrar General, High Court of Madras is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022 to Finance (BG-I/Home-II) Department at the appropriate time without fail.
