### **ORDER:-**

The Hon'ble Chief Minister of Tamil Nadu has made the following Announcement on the floor of the Tamil Nadu Legislative Assembly while replying to the demand for grant for Police Department [Demand No.22], on 21.04.2023:-

### **Announcement No : 33**

திருவள்ளூர் மாவட்டத்தில் உள்ள பொன்னேரி மற்றும் திருப்பாலைவனம் காவல் நிலையங்கள் நிருவாக வசதிக்காக ஆவடி மாநகர காவல் ஆணையரகத்துடன் இணைக்கப்படும். ஆவடி மாநகர காவல் ஆணையரகத்தின் எல்லை விரிவுபடுத்தப்படுவதோடு மக்களுக்கு சிறந்த காவல் சேவை வழங்க இயலும்.

2. Pursuant to the above announcement, Director General of Police/Head of Police Force, Chennai in the letter second read above has sent the proposal for Annexation of Ponneri Police Station and Thirupalaivanam Police Station of Thiruvallur District with Avadi Police Commissionerate which would be more effective in governing and patrolling the localities in much more efficient way.

3. The Government after careful examination have decided to accept the proposal of the Director General of Police/Head of Police Force, Chennai. Accordingly, the Government direct that Ponneri Police Station and Thirupalaivanam Police Station of Thiruvallur district be annexed with Avadi Police Commissionerate.

4. The Government also direct that the Commissioner of Treasuries and Accounts, Chennai to effect the remapping of Drawing and Disbursing Officers Code in IFHRMS portal consequent on the Annexation of Ponneri Police Station and Thirupalaivanam Police Station of Thiruvallur district with Avadi Police Commissionerate. The Government also direct that the Commissioner of Police, Avadi Commissionerate shall address the Commissioner of Treasuries and Accounts, Chennai along with copy of this order and the details of the posts to be remapped, with Post Code, present DDO Code and DDO code to which to be remapped so as to complete the remapping in IFHRMS portal.

In exercise of the powers conferred by section 13 of the Chennai City Police (Extension to the Cities of Avadi and Tambaram) Act, 2022 (Tamil Nadu Act 7 of 2022), the Governor of Tamil Nadu hereby makes the following amendment to Schedule-I to the said Act:-

In the said Schedule-I, after the entry "25. Vellavedu", the following entries shall be added, namely:-

"26. Ponneri

27. Thirupalaivanam".
