ORDER:

On 13.09.2021, in Budget 2021-2022 session, while replying to the demand for grant for Police Department, (Demand No.22), Hon'ble Chief Minister, among others, has made the following Announcement on the floor of the Tamil Nadu Legislative Assembly:-

Announcement No.15

A Special Cell will be created in the Office of the Director General of Police to redress the Grievance of Non-Resident Indians. The work of this Cell is to fastly enquire the complaints received through online and to inform the results of enquiry to the complainant.

- 2. Based on the above Announcement made by the Hon'ble Chief Minister of Tamil Nadu, the Director General of Police in his letter read above has sent a proposal for the creation of a Special Cell as follows:
 - (i) Around 35 lakhs of Tamils have migrated to various countries exploring their career opportunities. The NRIs have played a crucial role in the revival of economy of Tamil Nadu. There are lot of bogus recruiting agencies and fraudulent agents who extract money from the people who aspire to go to foreign countries in search of jobs. The families of Non-Resident Indians (NRIs)/ Persons of Indian Origin (PIOs) are facing number of problems as the patriarch of the house is always in foreign land and those families are often under constant threat of anti social elements. In order to safe guard the interest of these people police need to pay special attention.
 - (ii) The formation of "TN POLICE NRI CELL" will be under the direct supervision of Additional Director General of Police, Law & Order and the cell will be headed by a Superintendent of Police at the Police Headquarters.

2.1. FUNCTIONS OF TN POLICE NRI CELL

- The TN POLICE NRI CELL will receive the complaints of NRI's/PIO's and assign reference numbers and will send the same to the concerned Police Station / unit for enquiry and monthly reports will be collected from the concerned. NRI Cell will monitor and communicate the action taken on their compliant.
- NRI Cell has no power to register FIRs and the same is being done by the local police station according to their jurisdiction on cognizable matters.
- The cell will guide the people who need repatriation to Tamil Nadu from abroad on various issues.
- Also help in Police verification on visa or allied matters.

2.2. DUTIES AND ACTIVITIES

- Timely action will be taken by the Cell to redress the grievances with the help of the local Police Station having the concerned jurisdictional area.
- Furnishing information / legal advice to the complainants regarding the action taken by Police with regard to the petitions filed in the Cell.
- Grievances related to physical and mental harassment of NRIs at work place, action will be taken to repatriate them to their native by the timely intervention of the NRI Cell through the State Government.
- Closely monitoring the cases registered by the local police on the basis of the complaints received from NRIs and their family members.
- Any other matters being entrusted with the NRI Cell by the State Police Chief.

2.3. HOW TO CONTACT

- Complaints / Grievances can be lodged through the newly proposed TN POLICE NRI web portal.
- The NRIs can also contact the Superintendent of Police/Deputy Superintendent of Police or Inspectors of Police seeking any legal help with regard to their grievances through their mobile numbers and also through an official whatsapp number / telephone number or through a dedicated e-mail id.

2.4. ACTION TAKEN ON THE PETITIONS

- Directions will be given to the concerned Districts / Cities / units to conduct impartial enquiry and FIR will be registered by the local jurisdictional stations if necessary.
- The report received from Districts / Cities will be scrutinized at TN POLICE NRI CELL and it will be ensured that the petitioners are satisfied on the investigation / enquiry /action taken by the Police. If not satisfied, the enquiry / investigation will be escalated.
- Action taken details will be sent to the Complainant through mail after enquiry or investigation is completed.

Accordingly, the Government accord administrative and financial sanction for a sum of **Rs.1,47,01,708/-** viz., recurring expenditure as Rs.1,32,42,336/- and non-recurring expenditure as Rs.14,59,372/- for "Creation of a Special Cell in the Office of the Director General of Police to redress the grievance of Non-Resident Indians and for creation of 13 posts as detailed in Annexure to this order.

- 5. The expenditure sanctioned in paragraph-3 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director General of Police is requested to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as an advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director General of Police shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (Home-I/BG-I) Department without fail.
- 6. This order issues with the concurrence of the Finance Department vide its U.O.No.15944/Home-I/2022, dated 08.04.2022 and Additional Sanction Ledger No.0002(Two) and PSL No:202204 PSL 0149.
