- 2. The Registrar General, High Court of Madras has further stated that the above mentioned newly constituted courts have to be constituted as Motor Accidents Claims Tribunals and the Presiding Officers of the said Courts have to be appointed as Members of the Motor Accident Claims Tribunals under section165 (1) and (2) of the Motor Vehicle Act 1988 (Central Act 59 of 1988).
- 3. The Registrar General, High Court of Madras has, therefore, requested the Government to issue necessary orders publishing notification under Section 165(1)and (2) of the Motor Vehicle Act, 1988 (Central Act 59 of 1988) for constitution of the above said 19 Courts as Motor Accidents Claims Tribunals and appointment of the Presiding Officers of the said Courts as Members of the Motor Accidents Claims Tribunals. Accordingly, the Register General, High Court of Madras, has sent a draft notification with a request to publish the same in the **Tamil Nadu Government Gazette.**
- 4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the Notification appended to this order shall be published in the <u>Tamil</u> **Nadu Government Gazette.**
