### ORDER:

In the Government Order first read above orders were issued for sanction of a sum of Rs.17,75,43,000/- towards construction of multistoreyed building (Ground + 9 floors) for housing fire station and sections of Madras High Court.

2. The Registrar (Administration), High Court of Madras has stated that the during the Hon'ble Building Committee meeting which was held on 5.1.2022, the committee resolved to shift the Fire and Rescue Services Station to a part of the 0.57 acre of land recently handed over by the Metropolitan Transport Corporation in the south west corner of the High Court campus. The Committee has further decided to construct new nine storied building for housing various sections of Madras High Court by utilizing the amount of Rs.17,75,43,000/- which was already sanctioned in the Government order first read above instead of Construction of multistorey building for housing fire station and sections of Madras High Court.

3. The Registrar (Administration), High Court of Madras has also stated that the revised plan and estimate was obtained from the Engineer-in-Chief, Chief Engineer (G1) and Chief Engineer Chennai Region,

Public Works Department to the tune of Rs.19.10 crore for the year 2021-2022 with future escalation of Rs.21.01 crore for the year 2022-2023 and Rs.23.11 crore for the year 2023-2024 for construction of the proposed multi-storied building (Stilt +9 floor). He has further stated that the above estimate submitted by the Public Works was approved in the Building committee meeting held on 04.04.2022 and the amount Rs.1,34,57,000/- additional amount is required for construction of the proposed new nine storied building for housing various sections of Madras High Court.

4. The Government, after careful examination of the revised proposal of Registrar General (Administration), High Court of Madras have decided to cancel the order issued in the Government Order first read above and to accept the revised proposal of the Registrar (Administration), High Court of Madras as a fresh one. Accordingly, the Government hereby cancel the orders issued in G.O. (Ms) No. 421, Home (Cts-III) Department, dated 06.10.2021. The Government also accord sanction a sum of Rs.20,24,60,000/- (Rupees twenty crore twenty four lakh sixty thousand only) for construction of new nine storied building for housing various sections of Madras High Court.

5. The expenditure sanctioned in para-4 above shall be debited to the following head of account:-

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai is directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG-I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Engineer-in-Chief (Buildings) and Chief Engineer (Buildings), Chennai Region, Public Works Department, Chennai shall also send necessary draft explanatory notes for inclusion of this expenditure in the Final Supplementary Estimates for the year 2022-2023, without fail.

7. This order issues with the concurrence of the Finance Department vide its U.O.No.48/DS(B)/BGII, dated 14 .04.2022 with Additional Sanction Ledger No.37 (Thirty Seven)
