ORDER:-

In the letter second read above, the Commissioner of Prohibition and Excise has stated that the Managing Director, Tamil Nadu State Marketing Corporation Limited, among others, has requested that the Commissioner of Prohibition and Excise may permit Tamil Nadu State Marketing Corporation Limited, on its request in writing to destroy the stock with the consent of the supplier and without certificate from the Forensic Sciences Department, after ensuing that, there is no loss of revenue to the corporation or the Government. He has, therefore, sent proposal to amend rule 19-(A) of the Tamil Nadu Liquor (Supply by Wholesale) Rules, 1983 by incorporating rule 19-A (3) of the said rules.

2. The Government after careful examination of the proposal of the Commissioner of Prohibition and Excise have decided to accept the same. Accordingly, the following Notification will be published in the <u>Tamil Nadu Government Gazette.</u>

NOTIFICATION.

In exercise of the powers conferred by section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Liquor (Supply by Wholesale) Rules, 1983.

AMENDMENT.

In the said Rules, in rule 19-A, after sub-rule(2), the following proviso shall be inserted, namely:-

"Provided that notwithstanding anything contained in this sub-rule, on application received in this behalf from the Corporation and with the written consent of the supplier, the Commissioner may permit the Corporation in writing to destroy such stock in the presence of any Officer of the Prohibition and Excise Department authorized by him in this behalf, subject to the condition that there shall not be any loss of revenue to the Corporation or the Government. The Commissioner may impose any appropriate condition while granting such permission".
