ORDER:

The Hon'ble Chief Minister has made the following Announcement while moving the Police demand (No.22) on 13.09.2021:-

வழங்கப்படும். இந்த பணிக்காக கணினிகள் மற்றும் மென்பொருட்கள் புதிதாக கொள்முதல் செய்யப்படும். இதற்கான மொத்த தொடராச் செலவினம் ரூபாய் **33** கோடி ஆகும் "

2. In the letter second read above, the Director General of Police/Head of Police Force, Tamil Nadu, Chennai has stated that:-

i. During the year 2019, around 2800 candidates were kept in the waiting list for compassionate ground appointment to be posted as

Junior Assistant/Typist.

ii. Since, there was no feasibility for giving appointment to them as Junior Assistant/Typist immediately. 1562 posts of Data Entry Assistant posts were created and orders were issued in the G.O. first read above.

- iii. Apart from that, as on 31.03.2021, 759 candidates are in the waiting list for Compassionate Ground Appointment for appointment as Junior Assistant/Typist and their chance of getting employment as Junior Assistant/ Typist in the near future is remote as per the ratio prescribed. Also 252 proposals seeking compassionate ground appointment are under correspondence in various level with unit officers.
- iv. Further, 121 Police personnel who had died due to Covid-19 and proposals for compassionate ground appointment are also being received. Therefore, around 1132 candidates would be in the waiting list for appointment on compassionate ground from the year 2015. The details are as follows:-

In view of the position explained above, there is stagnation in the appointment of the wards of the deceased police personnel as Junior Assistants/Typists. The persons in the waiting list frequently represent their grievances seeking early appointment.

v. Considering the above, during the Budget Session-2021-2022 (Police Demand-22, Announcement No.7), on the Floor of Legislative Assembly, the Hon'ble Chief Minister has made the following Announcement on 13.09.2021:-

The DGP/HPF, Tamil Nadu has also stated that 2 posts of Data Entry Assistant were allotted to each Police Stations in the Cities and 1 post of Data Entry Assistant were allotted to each Police Stations in the Districts. In order to maintain uniformity for the allotment of Data Entry Assistants, additionally 1132 posts are required as follows:-

These 1132 posts of Data Entry Assistants/Reception staff can be filled with the persons in the waiting list for appointment as Junior Assistant/Typist on Compassionate Grounds. By this process, the candidates in the waiting list from the year 2015 to till date will be able to get an appointment on compassionate ground. As was done in the case of the Data Entry Operators earlier, these Data Entry Assistants/Reception staff would become Junior Assistant in the allotted quota of vacancies for compassionate appointment.

The DGP has also proposed to supply uniform to Data Entry Assistants, since, 1132 posts of Data Entry Assistant/Reception staff will be created by keeping equal no. posts of Grade II Police Constable in abeyance. The financial implication involved for the supply of uniform to Data Entry Assistant will be compensated in the savings of funds to be utilized for supply of uniform articles to 1132 Grade II Police Constables. Hence, there will be no additional expenditure involved in connection with supply of uniform articles to Data Entry Assistant. Further there will be no additional expenditure towards salary to the Data Entry Assistants/Reception staff, since they are to be accommodated in the posts of Grade II Police Constables which are to be kept in abeyance.

- 4. The Director General of Police/Head of Police Force has further requested the following and to issue orders :
 - a) The Data Entry Assistants (who are already appointed and to be appointed) will work as Data Entry Assistant, as well as the Station Receptionist on Rotation Basis as per the requirement of the Police Station. In this regard, necessary training will be provided by the Unit Officer Concerned.
 - b) The Government is requested to permit to fill up the post of Data Entry Assistants/ Reception staff from waiting list of Compassionate Ground Appointment whenever the incumbent in the post is promoted, retires from service or dies and the post gets vacant, in future.
 - c) As a welfare measure to the family members of the deceased Police personnel, the Government may consider this proposal favourably, since there would be no financial implication in salary and the system would also help to improve the Police Station work.
 - d) Seniority of the Data Entry Assistant/Reception staff will be decided on the basis of the date of death of deceased police personnel.
- 5. The Government after careful examination have decide to accept the above proposal of the Director General of Police/Head of Police Force, Tamil Nadu, Chennai with certain modifications. Accordingly, the Government order the following:
 - i. Sanction is accorded for creation of 1132 posts of Data Entry Assistant to work as Receptionist in the Police Station in the time scale of pay of Rs.18200 57900/- (Pay level 5) by surrendering 1132 posts of Grade II Police Constable and by filling up the above said posts from the candidates in waiting list of compassionate ground appointment for Junior Assistant/Typist. List of 1132 post of Grade II Constables surrendered in lieu of the newly created 1132 posts of Data Entry Assistants is shown in the Annexure to this order.
 - ii. The Director General of Police is permitted to proceed with appointment from the candidates who are in the waiting list for compassionate ground appointment as Junior Assistant/Typists in Tamil Nadu Police Department from the year 2015 to till date for the post of Data Entry Assistants/Reception staff.
- iii. If any candidates are unwilling for getting appointment as Data Entry Assistants/Reception staff, their names may be deleted from the list of candidates for getting compassionate ground appointment.

- iv. The candidates to be appointed as Data Entry Assistant/Reception staff will have to undergo 3 months training in the Training institutions of the Police Department on the following subjects.
 - a) Typewriting
 - b) Ms-Office / Basic computer operations
 - c) General station work
 - d) CCTNS
 - e) E-Office
 - f) Reception work (Soft Skill Training).
- Uniform code for the Data Entry Assistants/Reception Staff shall be decided by Director General of Police/Head of Police Force, Tamil Nadu, Chennai.
- vi. The work timing of Data Entry Assistant/ reception staff will be in two shifts on rotation basis and they are entitled for holiday on Sundays and Government holidays.
- vii. The service of every candidate appointed to the post of Data Entry Assistant, will be regularized after verification of certificates and will be on probation for a total period of two years on duty within a continuous period of three years.
- viii. The existing Data Entry Operators shall be appointed as Junior Assistants/Typists as per their seniority and availability of vacancies. As and when such appointments are ordered, equal number of Grade II Police Constable Posts which has already been kept in abeyance shall be revived.
 - ix. A reception staff in the cadre of Data Entry Assistant will perform the following works:
 - a) Receive public and hear the grievances.
 - b) Receive complaint from public and book CSR on a handheld device connected to a printer.
 - c) Will guide public/complainants regarding procedures and officers whom to meet.
 - d) Details of petitions received by Reception Staff can be seen by senior officer for effective supervision.
 - x. Seniority of the Data Entry Assistant/Reception staff will be decided on the basis of the date of death of deceased police personnel.
- 6. The expenditure will be met under the relevant head of account and the expenditure has to be debited under "01 Salaries -01 Pay" under relevant Sub- head of accounts under "2055 -00-Police".

- 7. Necessary additional provisions will be provided in the Revised Estimates 2022-2023/Final Modified Appropriation 2022-23. Pending provision of funds in Revised Estimates 2022-2023, the Treasury Officers concerned are directed to admit pay claims for the posts for the 1,132 posts of Data Entry Assistants sanctioned in this order. The Director General of Police is directed to calculate the funds required towards pay and allowances for the post of Data Entry Assistant for the year 2022-2023 from the date of filling up and include it in the proposals for Revised Estimates/Final Modified Appropriation 2022-23.
- 8. Further, the Government directs that the Expenditure items other than salary will be examined separately after the said posts are filled up and the Director General of Police /Head of Police Force, Tamil Nadu is directed to send necessary proposals in this regard for consideration of the Government at the appropriate time.
- 9. This order issues with the concurrence of Finance Department vide its U.O.No.18569 Finance (Home-I) Department, dated 22.4.2022 post sanction ledger No.PSL 202204 PSL 0156.
