<u>ORDER</u>

In the Government Order first read above, orders were issued for sanction and constitution of one more Judicial Magistrate Court at Arakkonam in Vellore District with posts and other requirements.

The Registrar-General, High Court of Madras, Chennai, in the letter second read above, has sent a draft notification under sub-section (1) of section 11 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), for constitution of one more Judicial Magistrate Court at Arakkonam in Vellore District with a request to publish the same in the <u>Tamil Nadu Government Gazette</u>.
