ORDER

In the Government order first read above, orders have been issued for sanction of an Additional Subordinate Judge's Court at Tiruchengode by upgradation of the existing Additional District Munsif's Court at Tiruchengode in Namakkal District.

- 2. Pursuant to this, the Registrar-General, High Court of Madras, has now forwarded draft notifications under Section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) for the purpose of constitution of an Additional Subordinate Judge's Court at Tiruchengode with a request to publish the same in the Tamil Nadu Government Gazette.
- 3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government direct that the following Notifications shall be published in the Tamil Nadu Government Gazette:-

NOTIFICATION-I.

In exercise of the powers conferred by first paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby alters the number of Subordinate Judges to be appointed under the said Act for Namakkal District as six with effect from the date on which the Additional Subordinate Judge assumes charge of the Additional Subordinate Judge's Court at Tiruchengode.

NOTIFICATION-II.

In exercise of the powers conferred by second paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby fixes the number of Subordinate Judges to be appointed for the Subordinate Judge's Court at Tiruchengode in Namakkal District as two with effect from the date on which the Additional Subordinate Judge assumes charge of the Additional Subordinate Judge's Court at Tiruchengode.
