<u>ORDER</u>

In the Government order first read above, orders have been issued, among others, for sanction of an Additional Subordinate Judge's Court at Tiruchengode by upgradation of the existing Additional District Munsif's Court at Tiruchengode in Namakkal District with posts and other requirements.

2. Pursuant to this, the Registrar-General, High Court of Madras, has sent draft notifications under section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) for alteration of the number of District Munsifs in the Namakkal District, with a request to publish the same in the Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government direct that the following Notification shall be published in the Tamil Nadu Government Gazette:-

NOTIFICATION-I.

In exercise of the powers conferred by the first paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby alters the number of District Munsifs to be appointed under the said Act for Namakkal District as seven with effect from the date on which the Additional Subordinate Judge assumes charge of the Additional Subordinate Judge's Court at Tiruchengode.

NOTIFICATION-II.

In exercise of the powers conferred by the second paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby fixes the number of District Munsifs to be appointed for the District Munsif's Court at Tiruchengode in Namakkal District as one with effect from the date on which the Additional Subordinate Judge assumes charge of the Additional Subordinate Judge's Court at Tiruchengode.
