Police – Budget session 2022-2023 – Announcement made by Hon'ble Chief Minister on the Floor of the Tamil Nadu Legislative Assembly - purchase of Computers and Accessories, Multi-purpose digital copier-cum-printer for the use of all the Police Stations in Tamil Nadu State – Administrative sanction in two phases and financial sanction in the first phase – Orders - Issued.

ORDER:

On 10.05.2022, in the Budget 2022-2023 session, while replying to the demand for grant for Police Department (Demand No.22), Hon'ble Chief Minister, has made among others, the following announcement:-

காவல் நிலையத்தில் விசாரணை மற்றும் பிற பணிகளை மேற்கொள்ள கணினிகள், அச்சுப்பொறிகள் போன்ற இன்றியமையாதவற்றை மாநிலத்தில் உள்ள 1507 காவல் நிலையங்களுக்கும் ரூபாய் 23 கோடி செலவில் வழங்கப்படும்.

2. Based on the above announcement, the Director General of Police / Head of Police Force has sent a proposal wherein he has stated as follows:

(i) Until the year 2007, 'Computers and accessories' for Police Stations had been purchased under Modernization of Police Force (MPF) Scheme. Since, the year 2008, the Government of India restricted purchase of certain items including 'Computers/ accessories, photocopier etc' under MPF scheme. Due to this reason, the 'Computers/accessories' supplied earlier to the Police Stations have become obsolete beyond repair.

(ii) The Computer & related accessories are prerequisites for effective functioning of Police Stations. For purpose of routine Police Station administration, Crime investigation, upkeep of Crime records, communication of Law and Order matters and supply of information/records to general public, requires computer accessories & printers.

(iii) It is necessary that all the Police Stations may be allotted new desktop computers, multi-purpose digital copier-cum-printer etc., The break up details of expenditure for 1527 Police Stations in Tamil Nadu is as follows:-

3. The Director General of Police / Head of Police Force has therefore, requested the Government to accord necessary administrative and financial sanction for a sum of Rs.22,90,50,000/- towards the purchase of 1527 Nos. (1507 + 20 newly formed AWPS) of Computers and Accessories, Multi-purpose Digital copier-cum-Printer for the use of all the Police Stations in Tamil Nadu State.

4. The Government, after careful examination of the proposal of the Director General of Police / Head of Police Force, Chennai have decided to accept it. Accordingly the Government accord administrative sanction for

purchase of 1527 Nos. of Computers and Accessories, Multi-purpose digital copier-cum-printer for the use of all the Police Stations in Tamil Nadu State in two phases at a total cost of Rs.22,90,50,000/- (Rupees twenty two crore ninety lakh and fifty thousand only). A sum of Rs.11,00,00,000/- (Rupees eleven crore only) is provided in Budget Estimates 2023-2024 under the relevant head of account for purchases in the first phase during 2023-2024.

5. The Director General of Police/ Head of Police Force is also directed to follow necessary purchase procedures while purchasing the Computers and Accessories, Multi-purpose digital copier-cum-printers. The Director General of Police/ Head of Police Force is directed to send necessary proposals to Government with the list of Police Stations to which computers and printers are to be provided in the first phase for according financial sanction after completion of purchase procedure. Further, Government direct that sanction of funds for further purchase of computers printers to the Police Station to which computers and printers are provided shall not be considered under CCTNS fund for the next 5 years.

6. This order issues with the concurrence of the Finance Department vide its U.O.No.32559/Fin (Home-I)/2023, dated 27.04.2023.
