### ORDER:

In the Government order first read above, orders were issued for constitution of an Additional District Court at Udumalpet in Tiruppur District with posts and other requirements.

2. Pursuant to this, the Registrar General, High Court of Madras, has now forwarded draft notification under Section 3-A of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) for the purpose of constitution of an Additional District Court at Udumalpet in Tiruppur District with a request to cause the same be published in the Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the following Notification shall be published in the Tamil Nadu Government Gazette:-
