ORDER:

WHEREAS, complaints have been received from a number of depositors that Messers Nirmal Krishna Benefit Fund @ Nirmal Krishna Nidhi Limited, Palugal Krishna Chits (Private) Limited and Nirmal Krishna Chits (Private) Limited, Kanniyakumari District have defaulted the return of deposits made by the depositors after maturity;

AND WHEREAS, the Government are satisfied that the said financial establishments are not likely to return the deposits to the depositors and hence, the Government have to protect the interests of such depositors;

AND WHEREAS, it is alleged that the Proprietor / partner of the said financial establishments has procured the immovable properties specified in Serial Numbers 1,2,3,4,5,6,7,9,10,12,13,14,15,16 and 17 of the Schedule to this Order from and out of the deposit collected by the Financial Establishments;

AND WHEREAS, since, the immovable properties specified above are not sufficient to repay the deposits to the depositors, it is proposed to attach other properties of the proprietor of the said financial establishments

viz., Thiru.K.Nirmalan, S/o. Krishnan Nair specified in Serial Numbers 8 and 11 of the Schedule to the order which were purchased prior to the commencement of business of the said Financial Establishments.

NOW, THEREFORE, in exercise of the powers conferred by section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997), the Governor of Tamil Nadu hereby makes an ad-interim order attaching the immovable properties which are standing in the name of Thiru.K.Nirmalan, who is the Managing Director of Messers Nirmal Krishna Benefit Fund @ Nirmal Krishna Nidhi Limited, Palugal Krishna Chits (Private) Limited and Nirmal Krishna Chits (Private) Limited, No.17/E1, E2, E4-Mathempalai, Palugal Post, Kanniyakumari District as specified in the Schedule to this order and transfers the control over the said immovable properties to the Competent Authority, namely, the Competent Authority and District Revenue Officer, Kanniyakumari District @ Nagercoil appointed under the said Act.

- 2. The Competent Authority and District Revenue Officer, Kanniyakumari District @ Nagercoil is requested to pursue further action in accordance with the procedure laid down in sub-sections (3) and (4) of section 4 of the said Act and also the formalities prescribed in the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Rules, 1997.

The Special Public Prosecutor, Special Court for the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997, Madurai is requested to render necessary assistance to the Competent Authority and District Revenue Officer, Kanniyakumari District@ Nagercoil for filing the application before the said Special Court.
