ORDER :-

In the Government order first read above, the Government have accorded administrative sanction for a sum of Rs.273.00 lakhs towards the Purchase of 13 Numbers of X Ray Baggage to 13 District Jails in the State.

2. The Director General of Police / Director General of Prisons and Correctional Services has stated that tender was floated through Gem Portal on 21.06.2023 and the tender was opened on 20.07.2023 in the presence of Tender Scrutiny Committee. On completion of scrutiny of Tenders and technical Committee's evaluation, M/S. Time Watch Infocom Pvt Ltd., New Delhi has emerged as successful bidder as the firm quoted the lowest rate for the supply of X-Ray Baggage Scanners 13 Nos. a total cost of Rs.2,72,35,000/- Hence, Purchase order were placed with the above firm on 01.11.2023. The firm has supplied X- Ray Baggage Scanner and installed in all 13 District Jails on 18.01.2024 and 22.01.2024.

3. The Director General of Prisons and Correctional Services has therefore requested the Government to accord financial sanction for a sum of Rs.2,72,35,000/- (Rupees two crore seventy two lakhs and thirty five thousand only) as non-recurring towards the purchase of 13 numbers of X Ray Baggage for 13 District Jails in the State, under the relevant head of account and to authorize him to draw and disburse the amount and also for provision of funds in RE 2023-2024. He has further requested to issue necessary instruction to the Pay and Accounts Officer (East) to admit and honor the bill for the above said amount under the relevant head of account pending provision of funds in the RE 2023-2024.

4. The Government after careful examination of the proposal of the Director General of Prisons and Correctional Services, Chennai have decided to accept the same. Accordingly, sanction is accorded for a sum of Rs.2,72,35,000/- (Rupees two crore seventy two lakhs and thirty five thousand only) as non-recurring expenditure towards the purchase of 13 numbers of X Ray Baggage for 13 District Jails in the State, Subject to ensure that the scanners have been supplied by the firm and are in order as per the terms and conditions.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

"2056-00-Jails-101 Jails - I- State's Expenditure - AA
- Jails (Other than sub Jails) 319. Machinery and equipments-01. Purchase.
IFHRMS (DPC - 2056-00-101-AA 31901)".

6. The expenditure sanctioned in para 4 above shall be met from the existing budget provision available in the FMA-I 2023-2024.
