#### ORDER:-

In the Government order first read above, the Government have accorded administrative sanction for a sum of Rs.35.00 lakhs towards the Purchase of 28 numbers of Flour Mills with its accessories (each 2 numbers) to 9 Central Prisons and 5 Special Prisons for woman in the State.

- 2. The Director General of Prisons and Correctional Services has also stated that tender was floated through Gem Portal on 13.07.2023 and the tender was opened on 07.08.2023 in the presence of Tender Scrutiny Committee. On completion of scrutiny of Tenders and technical Committee's evaluation, M/s.Universys Technologies Private Limited has emerged as successful bidder as they quoted the lowest rate for the supply and installation of 28 Numbers of Flour Mills with its accessories and civil works for the Flour Mills at a cost of Rs.36,67,440/- (Rupees thirty six lakhs sixty seven thousand four hundred and forty only) and cost per unit is Rs.1,30,980/-. Hence, Purchase order was placed with the above firm on 16.02.2024.
- 3. The Director General of Prisons and Correctional Services has therefore requested the Government to accord financial sanction for a sum of Rs.36,67,440/- (Rupees thirty six lakhs and sixty seven thousand four hundred and forty only) as non-recurring towards the Purchase of 28 numbers of Flour Mills with its accessories (each 2 numbers) to 9 Central Prisons and 5 Special Prisons for woman in the State, under the relevant head of account and to authorize him to draw and disburse the amount and also for provision of funds in RE 2023-2024. He has further requested to issue necessary instruction to the Pay and Accounts Officer (East) to admit and honor the bill for the above said amount under the relevant head of account pending provision of funds in the RE 2023-2024.

- 4. The Government after careful examination of the proposal of the Director General of Prisons and Correctional Services Chennai have decided to accept the same. Accordingly, sanction is accorded for a sum of Rs.36,67,440/- (Rupees thirty six lakhs and sixty seven thousands four hundred and forty only) as non-recurring towards the Purchase of 28 numbers of Flour Mills with its accessories (each 2 numbers) to 9 Central Prisons and 5 Special Prisons for woman in the State, subject to condition that to ensure that the supplier has completed the work as per the agreement and the amount should not be drawn and kept in bank account.
- 5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

"2056-00-Jails-101. Jails - I- State's Expenditure - AA - Jails (Other than sub Jails) 319. Machinery and equipments-01 Purchase." (IFHRMS DPC - 2056-00-101-AA 31901).

- 6. The expenditure sanctioned in para 4 above shall me met from the existing budget provision available in the FMA-I 2023-2024.
- 7. This order issues with the concurrence of the Finance Department vide its U.O.No.e.1747/Finance (Home-II) Department/2024-1, dated 14.03.2024.
