ORDER:

In the Government Order first read above, the Government enhanced the Extra Time Remuneration from Rs.150/- to Rs.200/- per day for the Police Constables to Head Constables with effect from 01.07.2010.

2. While replying to the debate on Police demand, the Honourable Chief Minister of Tamil Nadu has made the following announcement, during the Police demand for the year 2020-2021, on the floor of Assembly on 24.03.2020.

"காவல் ஆளிநாகளின் மிகை நேரப்பணிக்கான மதிப்பூதியம் (ETR) ரூ.200/– லிருந்து ரூ.500/– ஆக உயாத்தி வழங்கப்படும். இதற்காக அரசுக்கு ஆண்டொன்றுக்கு ரூ.160.34 கோடி செலவாகும்."

3. Accordingly, the Director General of Police has sent proposal to Government for the enhancement of Extra Time Remuneration charges from Rs.200/- to Rs.500/- from the rank of Grade - II Police Constables to Head Constables with a financial sanction of Rs.160,35,55,200/- (Rupees One hundred sixty cores thirty five lakhs fifty five thousand and two hundred only) per annum.

- 4. After detailed examination, the Government accept the above proposal of the Director General of Police, Chennai and accordingly enhance the Extra Time Remuneration from the existing rate of Rs.200/-to Rs.500/- per day for Police personnel (Grade II Police Constables to Head Constables) those who are drafted for duty during their weekly off. The Government direct that, the Extra Time Remuneration should not be sanctioned/claimed an automatic entitlement but paid based on actual duty done by the Police personnel. This order shall take effect from the date of issue of this order.
- 5. The Director General of Police, Tamil Nadu, Chennai is directed to calculate the head of accountwise additional fund requirement and send necessary proposal to Government for making necessary provisions in the Final Modified Appropriation 2020-2021 and BE 2021-2022.
- 6. This order issues with the concurrence of the Finance Department, vide its U.O.No.257/FS/P/Home-1/2021, Dated 13.01.2021.
