ORDER:

The Hon'ble Chief Minister on the floor of the Legislative Assembly during the Budget Session for the year 2022-2023 in respect of the Forensic Sciences Department, among other things, has made the following announcement:-

In pursuant to the Announcement and based on the proposal of the Director(i/c), Forensic Sciences Department, Chennai, in the Government Order first read above, the Government accorded administrative sanction for creation of 8 new posts and for a sum of Rs.4,77,34,003/- towards creation of Forensic DNA Analysis Division(Rs.3,79,18,920/-) and towards augmenting the capabilities of Digital Forensic Analysis (Rs.98,15,083/-) at the Regional Forensic Science Laboratory, Coimbatore, as detailed below:

In the Government Order second read above, the Government accorded permission to the Director(i/c), Forensic Sciences Department, Chennai to fill up the 4 (four) new posts created in the Government Order first read above, for carrying out digital analysis in the Regional Forensic Science Laboratory, Coimbatore.

In the circumstances reported by the Director(i/c), Forensic Sciences Department, Chennai, in his letter third read above, the Government accord revised administrative and financial sanction for a sum of Rs.58,90,803/- (Rupees fifty eight lakh ninety thousand eight hundred and three only) i.e Rs.7,56,265/- over and above the administrative sanctioned amount of Rs.51,34,538/- vide Government Order first read above, for purchase of software/hardware tools and for purchase of furniture towards augmenting the capabilities of Digital Forensic Analysis at the Regional Forensic Science Laboratory, Coimbatore.

5. The expenditure sanctioned at para-4 above, shall be debited to the following heads of account:-

7. The Director(i/c), Forensic Sciences Department, Chennai is directed to follow the existing purchase and tender procedures as per rules inforce.
