The following Notification will be published in the Tamil Nadu Government Gazette, Extraordinary, dated 12th May, 2023.

NOTIFICATION.

In exercise of the powers conferred by Section 10 of the Tamil Nadu Cinemas (Regulation) Act, 1955, (Tamil Nadu Act IX of 1955), the Governor of Tamil Nadu, hereby makes the following amendments to the Tamil Nadu Cinemas (Regulation) Rules, 1957.

AMENDMENTS

In the said Rules,-

- (1) in rule 45, for the expression "Joint Commissioner of Land Administration", the expression "Joint Commissioner of Revenue Administration" shall be substituted;

- (2) in rule 83, in sub-rule (1-B), for the expression "Joint Commissioner of Land Administration", the expression, "Joint Commissioner of Revenue Administration" shall be substituted;
- (3) in rule 115-A,-
 - (a) in sub-rule (9), for the expression "Joint Commissioner of Land Administration" the expression "Joint Commissioner of Revenue Administration" shall be substituted;
 - (b) in sub-rule (10), for the expression "Joint Commissioner of Land Administration" the expression "Joint Commissioner of Revenue Administration" shall be substituted;
- (4) in rule 128, for the expression "Joint Commissioner of Land Administration" the expression "Joint Commissioner of Revenue Administration" shall be substituted;
- (5) in rule 128-A, for the expression "Joint Commissioner of Land Administration" the expression "Joint Commissioner of Revenue Administration" shall be substituted.
