



## **ABSTRACT**

Police – Buildings –Construction of Police Public Higher Secondary School building at Melakottaiyur in Chengalpattu District – Financial sanction accorded- Orders – Issued.

In the Government Order first read above, the Government have accorded administrative sanction for a sum of Rs.51.15 crore (Phase-I: Rs.2493.24 lakh and phase-II :Rs.2621.74 lakh) for establishment of Police Public School of Melakottaiyur.

2. In Government Order second read above, the Government have accorded financial sanction for a sum of Rs.5.00 crore under Phase-I towards the Construction of School building for the above Police Public School and ordered that the Government will consider further release of amount based on the progress of work furnished by the Director General of Police. In the Government Order third read above, the Government have sanctioned Rs.40.00 lakh for purchase of furniture for the above school.

3. The Director General of Police/ Head of Police Force, in the letter fourth read above, has stated as below:

(i) The Government have accorded financial sanction for a sum of Rs.5.00 crore towards the construction of Residential Police Public Higher Secondary School building with development works at Melakottaiyur in Chengalpet District and the Government has informed that the release of amount will be considered based on the progress of work. Accordingly, a sum of Rs.5.00 crore was claimed and utilized for the construction of primary School building at Melakottaiyur in Chengalpet District.

(ii) The Chairman and Managing Director, Tamil Nadu Police Housing Corporation Limited has stated that in order to construct the remaining buildings, a detailed discussion was held with the user department officials, (i.e.) Additional Director General of Police (Welfare), Inspector General of Police (Welfare) along with Tamil Nadu Police Housing Corporation Limited officials on 08.11.2019, wherein the Additional Director General of Police (Welfare) has instructed to carry out the works before May 2020, so as to commence the school admission in the forth coming academic year and accordingly the estimate has been prepared as given below:-

(iii) Further the Chairman & Managing Director, Tamil Nadu Police Housing Corporation Limited has stated that Tamil Nadu Police Housing Corporation Limited, has been instructed to commence the construction works for Higher Secondary School buildings (IX to XII Std.) immediately. Accordingly, the construction works has been taken up and under progress.

4. The Director General of Police has, therefore, requested the Government to accord financial sanction for a sum of Rs.942.34 lakh for construction works for Higher Secondary School buildings (IX to XII Std.) at Melakottaiyur in Chengalpet.

5. Subsequently, the Chief Engineer, Tamil Nadu Police Housing Corporation Limited has furnished the details of funds received / to be received as follows:-

6. The Government, after a careful examination, have decided to accord financial sanction for a sum of Rs.6.93 crore (Rupees six crore ninety three lakh only) for the construction works of Police Higher Secondary School building at Melakottaiyur in Chengalpattu District (Phase-I).

7. The Government also direct that the construction work be entrusted to the Tamil Nadu Police Housing Corporation Limited. The Chairman and Managing Director, Tamil Nadu Police Housing Corporation Limited is directed to ensure that the construction work is completed within the sanctioned amount or tendered value of work, whichever is less.

8. The expenditure shall be debited to the following head of account:-

"2055 – 00 - Police – 001 – Direction and Administrative – State's Expenditure – AQ Assistance to Police Public School Society- 109 Grants in AID –01 Grants for creation of capital Assistance"

(DPC 2055 – 00 – 001 – AQ – 0927)

9. The amount sanctioned in paragraph 6 above shall be drawn by the Director General of Police, Chennai on the basis of progress of work and Utilization Certificate submitted to Director General of Police by the Tamil Nadu Police Housing Corporation Limited and should be contra credited into Personal Deposit Account of Tamil Nadu Police Housing Corporation Limited under the following head of account:-

"K-Deposits and Advances (b) Deposit not Bearing Interest – 8443 00 Civil Deposits – 800 Other Deposits – BL – Deposits of Tamil Nadu Police Housing Corporation Limited

(DPC 8443 00 800 BL 000A)(Receipts)

(DPC 8443 00 800 BL 0000)(Outgoings)

10. The Director General of Police is directed to ensure that the Utilization Certificate is obtained on completion of work and claim refund of any un-utilized amount at the end of work. The Director General of Police is

also directed not to release the amount on adhoc basis / lumpsum and to remit the tender savings amount in the Government Head of account.
